SUBJECT: Department of Defense Energy and Environment Innovation Symposium Approval and Logistics

The Department of Defense (DoD) Energy and Environment Innovation Symposium is set to take place November 28 through December 1, 2023, at the Crystal Gateway Marriott in Arlington, VA. This event is being hosted by Strategic Environmental Research and Development Program (SERDP), Environmental Security Technology Certification Program (ESTCP), Operational Energy Capability Improvement Fund (OECIF), and Operations Energy Prototyping Fund (OEPF). The enclosed approval to hold this in-person event was granted by the Under Secretary of Defense for Acquisitions and Sustainment and covers up to 299 DoD attendees.

The hotel is approximately two miles from National Airport (DCA) and is accessible through public transportation or car service. Rental cars should not be necessary in most instances. Breakfast and lunch will be provided for all registrants at the hotel on November 28th, 29th, and 30th. Breakfast will be provided December 1st.

SUBJECT: Strategic Environmental Research and Development Program and Environmental Security Technology Certification Program Symposium

- Request your approval to hold the Strategic Environmental Research and Development Program (SERDP) and Environmental Security Technology Certification Program (ESTCP) Symposium in Washington, DC, on a recurring annual basis from 2021 to 2025.
- The Department of Defense (DoD) spends approximately \$7.5 billion annually on environmental issues and facility energy. SERDP and ESTCP invest approximately \$100 million annually to develop, demonstrate, and transfer technologies to address these issues.
- Symposium technical sessions will be aligned with SERDP and ESTCP priorities, including increasing training land availability, corrosion control on weapons systems to improve sustainment, remediation of contaminants such as PFAS, underwater unexploded ordnance detection and removal, and installation energy security and resilience.
- The SERDP and ESTCP Symposium assembles researchers and technology developers with the defense user and regulatory communities to facilitate technology transfer of innovative environmental and installation energy technologies.
- The estimated cost of the 2021 Symposium to the DoD is \$475,074 (TAB A) and recurring events are capped at \$500,000. Planning for the Symposium will begin in early 2021.
- Symposia from 2017 through 2020 were approved on an annual basis. This Symposium is now a well-established annual event so recurring approval is warranted. Justification including historical attendee and cost data is at TAB B.
- Per Deputy Chief Management Officer Memorandum, “Updated Department of Defense Conference Guidance,” dated June 26, 2016, all recurring conferences hosted by the Office of the Under Secretary of Defense for Acquisition and Sustainment Components must be submitted for Under Secretary of Defense for Acquisition and Sustainment approval.
