Your Resource Marketplace Table will include:

- One (1) 30"x6' draped table (Black)
 - *If you have selected an L-shaped space with two (2) tables, you must provide the 2nd table. Only ONE (1) table will be provided to you.*
- Two (2) chairs
- Power outlets are very limited and access cannot be guaranteed. Please assume that you will not have access to power at your table and plan accordingly.
- The hotel offers complimentary wifi. Simply connect to "Tulalip_Guest" while on Gaming floor and public areas at all properties or to "HotelConf" while in the Hotel meeting rooms and foyers. There is no password required.
- *Onsite drayage (hotel storage and handling fees) are not included. Resource participants are responsible for any shipping and receiving charges. You must ship directly to your hotel room and fees will apply - up to \$30 per 100 Pounds.*
- *Please note: Overnight Security will not be provided. Please plan to secure anything needed overnight (laptops, etc.).*
