

- If the student needs services, they must be directed to the school site representative at their assigned school.

# SCHOOL SITES REPRESENTATIVE DUTIES

- Annually, each school-site administrator will designate a McKinney-Vento & Foster Representative(s).
- Housing Questionnaire should be completed every time there is a change of living situation.
- Have your Records Clerk follow up with the students CUM Folder.
- Review and verify Monthly CALPADS Report at the school site that are sent out by the district liaisons.
- OLR Registration summer before the new school year begins and in January
- The McKinney-Vento Representative will conduct and interview with the parent and accurately complete the McKinney-Vento-Foster Youth referral.
- Have the ADDRESS on the Referral reflect information on Synergy.
- Input the CODE (McK/Foster) on the STUDENT NEEDS SCREEN.
- If the student has shared information that they are homeless, please make sure you contact the guardian.











# IDENTIFICATION PROCESS: ONLINE VERIFICATION

#### **OLR Verification Process 2025-2026**

Most parent submissions will be auto-accepted when there are no changes made, with the exception of McKinney-Vento/Foster, Heath Conditions/Medication, and Address updates. The verification will be made by the corresponding staff role, Secretary for address updates, the Health Clerk/Nurse for health conditions/medications, and McKinney/Foster Liaisons for homeless information.

- Start by searching for the Registration Queue in quick launch.
- 2. Make sure you change focus year to 2025-2026.
- In the Registration Queue screen you will see the Registrations tab.
- 4. In the OLR Setup drop down, you will see Verification for existing students. There is also an option for New Student, those are not to be processed, parent probably submitted wrong verification. School staff can delete those and guide the parent to select the correct option.
- 5. You will also see the Total Pending Registrations.
- There will be a message that reads Review Required Prior to Accept for Any Registrations with Critical Changes.
- 7. You will now see the Registration Flags. Those flags include Foster, McKinney, Health, and Address.
- The flags will be listed for each student in the columns. Depending of your role, you will be verifying that submission. For example, a health flag, health clerk or nurse will accept.
- 9. If you see that there are more than one flag checked, you must follow the next process.
- 10. In the Note column, you can click on the OLR:Auto-Accept... hyperlinked text.













### INTEGRATED STUDENT SUPPORT SERVICES





- The McKinney-Vento Representative will conduct and interview with the parent and accurately complete the McKinney-Vento-Foster Youth referral.
- Have the ADDRESS on the Referral reflect information on Synergy.
- Input the CODE (McK/Foster) on the STUDENT NEEDS SCREEN.
- Once resources have been provided The McKinney- Vento Representative will submit the referral to the district's Foster Youth Liaison, for further follow up.
  - Transportation
  - Housing
  - Clothing
  - Shoes
  - Toiletries
  - Backpack & School Supplies
- Thus far we have received 364 referrals 2024-2025 school year



### TRANSPORTATION SERVICES



We provide two reliable transportation options to ensure our homeless youth students have consistent school access to education:

- Rialto Unified School District Transportation:
  - Supports student participation in **all academic and extracurricular activities**, including:
    - Zero Periods
    - 7th Period
    - Think Together (After School Program)
    - Senior Events
    - After School Tutoring
- EverDriven (Third-Party Contract):
  - Offers door-to-door pick-up and drop-off for students with unique transportation needs.

Our goal is to remove transportation barriers so every student can attend school consistently and participate fully in their educational journey.









# Steps for Providing Housing Resource Supports at the District Level

- Referral Received from the School Site
  - School site staff submit a referral indicating the family's need for housing assistance.
- 2. Needs Assessment & Urgency Evaluation
  - The District Liaisons evaluates the family's level of urgency and identifies the most appropriate support services.
  - A meeting is scheduled to build rapport and complete a Housing Assessment Form, collecting details about the current living situation.
- 3. Resource Provision
  - Based on the assessment, support may include:
    - A 90-day stay at our district contracted hotel
    - With Open Arms Referral Financial assistance (rent, utilities, or move-in costs)
    - Employment or housing search support during temporary housing
- 4. Initial Contact Third Party Housing Program
  - With Open Arms staff contacts the family to confirm the referral and set up an appointment.
- 5. Follow-Up & Support Continuation
  - Ongoing communication is maintained to support housing stability and ensure resource use is effective.









# HOUSING RESOURCE: WITH OPEN ARMS HOUSING ASSISTANCE PROGRAM

With Open Arms provides comprehensive housing navigation services for families, especially those in need of low-income or general housing support. In partnership with the Rialto Unified School District through an annual contract, the organization offers the following resources:

- Assistance with housing searches and applications
- Help obtaining or replacing vital documents such as birth certificates, Social Security cards, and California ID waivers
- Financial support including:
  - Up to \$1,000 for rental assistance or move-in costs
  - Utility assistance
  - A \$1,000 Walmart gift card (requires proof of a rental agreement)

With Open Arms Housing Referrals - Progress Update

- 43 housing referrals have been submitted
- 19 families have received rental assistance
- 2 cases are currently pending
- 22 families are in follow-up status

We are committed to continuous improvement and actively working to support the remaining families in accessing the \$1,000 assistance.









#### TEMPORARY HOUSING RESOURCE

Rialto Unified School District partners with WoodSpring Suites to provide short-term emergency housing for families in crisis, including those who are unhoused, living in vehicles, or recently evicted.

#### Program Details:

- 90-Day Stay: Families are offered up to 90 days of emergency housing. (May be extended, contingent on funding)
- Required Documentation: A district hotel contract must be completed reviewing grades and attendance. Including an indemnity waiver signed by the family.
- Accommodations:
  - Single or double rooms available
  - o Each room includes a small kitchen area with a stove
  - o Free Wi-Fi access provided
  - Hotel amenities

Purpose - This emergency placement is designed to give families stability and time to:

- Save for future housing
- Seek employment
- Engage with With Open Arms programs for rental assistance and long-term support.

#### Emergency Hotel Placements - Impact Update

- 26 hotel placement contracts submitted
- 25 families assisted
- 60 students supported through emergency housing

Rialto Unified School District continues to provide stable, short-term housing to ensure families and students have a safe place to stay during times of crisis.









### **SCENARIOS**

Megan Williams is a third grader at Dunn Elementary School. She informed her teacher, Ms. Ramirez, that her family was evicted last night and that she no longer has clothes. Megan has a kindergarten sibling at Dunn, as well as two other siblings attending Carter High and Kolb Middle School.

Question: What steps will you take to support Megan and her family?

Nick Vielman is a seventh grader who has been arriving late to school for the past two days. When questioned by the attendance clerk, he disclosed that he recently moved in with his grandparents because his mom relocated to another state for work. However, his grandparents are unable to drive him to school.

Question: What steps will you take to support Nick?





